There is one (1) minor child as the expected issue of the parties an unborn minor child with a
detectable heartbeat, With an Expected Date of Birth: _____.

Petitioner is entitled to an order of paternity for the unborn minor child of the parties that legally
establishes said minor child as Respondent's progeny.

5.

Petitioner is entitled to an award of support from Respondent for the maximum amount of
support which this court may impose on the father of an unborn minor child under O.C.G.A. § 19-

6-15 for the amount of direct medical and pregnancy related expenses of the Petitioner for the unborn minor child.

6.

Upon the birth of the minor child, the Petitioner is entitled to an award of temporary and permanent child support for the maintenance, care and support of the minor child based upon the statutory guidelines and pursuant to Georgia law.

7.

Upon the birth of the minor child, Petitioner is entitled to an award of temporary and permanent physical and legal custody of the minor child, on the following grounds:

- a. Petitioner is the natural mother of the minor child;
- b. The minor child is expected to reside full-time with Petitioner;
- c. Such an award will be in the best interest of the minor child;

Petitioner is entitled to an award of support arrearages from Respondent as reimbursement for all costs Petitioner incurred as a result of prenatal, neonatal and post-natal care for herself and the minor child since conception.

9.

Petitioner is entitled to any other further relief and awards deemed necessary and proper by this Honorable Court.

WHEREFORE Petitioner prays that:

- A) Rule Nisi issue;
- B) The Court issues an order of paternity for the unborn minor child of the parties that legally establishes the child as Respondents progeny;
- C) The Court award Petitioner an award of support from Respondent for the amount of direct medical and pregnancy related expenses of the Petitioner for the unborn minor child;
- D) Upon birth of the minor child, the Court awards Petitioner temporary and permanent sole physical and sole legal custody of the minor child;
- E) Upon birth of the minor child, the Court orders Respondent to pay temporary and permanent child support to Petitioner for the maintenance, care and support of the minor child based upon the statutory guidelines and/or pursuant to Georgia law;

- F) That Petitioner reserves the right to amend her Petition to allege additional grounds and prayer for relief subsequent to the filing of her Petition and/or upon discovery thereof; and
- G) For any other further relief and awards deemed necessary and proper under the facts by this Honorable Court.
